1.1 The following preference point systems are applicable to invitations to tender:

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
 - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

**APPOINTMENT OF A QUALIFIED SERVICE PROVIDER TO CONSTRUCT AN
EMERGENCY ENTRANCE/EXIT IN THE CHAMBER ROOM**

1. INTRODUCTION

- 1.1 The National Economic Development and Labour Council (Nedlac) is a statutory body that was established through the Nedlac Act No. 35 of 1994 and operates under the terms of the Nedlac Constitution. Nedlac's vision is to promote growth, equity and participation through social dialogue.
- 1.2 Nedlac has one office nationally with an employee compliment of +-fifty (50) staff members and external stakeholders/social partners. Before the Covid-19 pandemic, on average +- sixty (60) people would use the facilities on a daily basis. The office is situated at 14A Jellicoe Avenue in Rosebank, Johannesburg.

2. PURPOSE

- 2.1 The purpose of this Request for Proposal (RFQ) is to invite reputable, accredited and experienced service providers with commercial building construction expertise to bid for the construction of an emergency entrance/exit and extension of the current entrance/exit door in the chamber room of at Nedlac House.

2.2 The objective of this exercise is to ensure compliance of the chamber room with fire safety requirements.

3. SCOPE OF WORK

3.1 The service provider is required construct an emergency entrance/exit, extend the current entrance/exit to a double door, construct evacuation ramps and rearrange existing furniture in the areas of the chamber room that will be affected by the construction of the entrance/exit as well as supply and install relevant safety signage.

The construction work should include the following:

- a) Demolish two windows on the front side of the chamber room, arch lintels and internal window pier.
- b) Construct an opening for a new entrance/ exit door spanning across two windows on the front side of the chamber room.
- c) Construct a steel platform and ramp to access the new entrance/ exit door. Dimensions of ramp to comply with SANS 10400 Part S and T to satisfy requirements for access for people with disabilities and fire protection requirements.
- d) Construct a wheelchair ramp leading to the entrance/exit in the chamber room.
- e) Construct low impact concrete bollards around the steel access to protect it from vehicle impact.
- f) Extend the current entrance and exit door in the chamber room to a double door entrance/exit.
- g) Supply and install all required building materials.
- h) Supply and install quality industry approved and SABS approved materials relevant to the services required.

3.2 Service provider must have a safety plan for the project.

3.3 Protective clothing must be provided to the construction workers.

3.4 Service provider to conduct a site visit prior to quoting.

3.5 Service provider to issue Nedlac with warranty for work done and guarantee on materials installed.

4. REQUIREMENTS OF THE SERVICE PROVIDER

4.1 The successful service provider must meet the following mandatory requirements:

- a) Be a registered building contractor with proven expertise in commercial building construction and alterations.
- b) Provide up to date accreditation by the NHBRC and CIDB.
- c) Provide up to date COID registration.
- d) Provide a safety file. Failure by the service provider to adhere to the safety Act, will result in immediate termination of the contract.
- e) Have a minimum of five (5) years in commercial building construction and alterations.
- f) Provide Nedlac with a project plan outlining the project deliverables, timelines and costs.
- g) Provide certified copies of trade certificates.
- h) Provide a list of similar projects completed in the last five (5) years.

- i) Provide at least five (5) signed reference letters and contactable references for similar projects completed in the last five (5) years.
- j) Provide a company profile.

5. SUBMISSION OF DOCUMENTS

Service providers must submit the following documents:

- 5.1 Budget indicating the maximum amount for the assignment.
- 5.2 Proof that the firm is in good standing with the South African Revenue Services (SARS).
- 5.3 BBBEE certificate or affidavit.
- 5.4 CSD registration.
- 5.5 Completed SBD forms.

6. SELECTION AND EVALUATION CRITERIA

6.1 Evaluation Criteria

As this procurement is expected not to exceed a maximum of R50 million, the 80/20 preferential procurement measure is applicable. In order to achieve specific goals, a maximum of 20 points will be awarded to a bidder/tenderer for broad-based black economic empowerment as follows:

- B-BBEE status Level 1 contributor: 20 points
- B-BBEE status Level 2 contributor: 16 points
- B-BBEE status Level 3 contributor: 10 points
- B-BBEE status Level 4 contributor: 8 points
- B-BBEE status Level 5 contributor: 6 points
- B-BBEE status Level 6 - 8 contributor: 0 points
