GENERAL CONDITIONS

i.6 The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

(e) “the Act” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
 - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

REQUEST FOR QUOTATIONS

1. PURPOSE

Nedlac requires a suitably qualified, experienced service provider to assist Nedlac with desktop publishing services.

2. BACKGROUND

The National Economic Development and Labour Council (Nedlac) is a schedule 3A public entity that falls within the Department of Employment and Labour. Nedlac is the vehicle by which Government, labour, business and community organisations seek to cooperate, through problem-solving and negotiation, on economic, labour and development issues and related challenges facing the country.

Nedlac is managed by a secretariat, consisting of about 50 staff members and led by an Executive Director.

Nedlac does not have capacity in its Communications Unit and requires assistance of a desktop publishing provider to provide desktop publishing services monthly for a newsletter as well as other ad hoc requirements.

3. SCOPE OF WORK

The successful service provider will be required to deliver the following:

3.1. Nedlac Connect Newsletter

- Design and layout of a newsletter once per month for online publishing
- Export newsletter to pdf of not more than 8 pages
- Prepare mobile friendly version of newsletter
- All written copy related to the newsletter will be provided.
- Service provider to source and site all related pictures if not provided

3.2. Nedlac Publications

- Be available to layout, design and proofread Nedlac publications (e.g. reports, summaries, concept documents, brochures) as and when required
- Upload final files for online publishing
- Export print ready and digital files of final publications

3.3. Nedlac Presentations and Document

- Use specialist computer design software to prepare designs and produce layouts
- Edit graphics, such as images or illustrations
- Import text and graphics into publishing software
- Produce computer visuals/rough sketches for approval
- Edit Nedlac document templates as and when required

3.4. Event Branding

- Design media such as physical and digital banners, powerpoint template, backdrop etc for the Nedlac Summit which is held annually.

4. REQUIREMENTS OF THE SERVICE PROVIDER

The successful service provider must provide some of the following to demonstrate experience in Adobe Creative Suite, CorelDraw, Illustrator, Microsoft Publisher and creating page layouts for electronic publications:

- 4.1. Detailed c.v. of the project manager and team members
- 4.2. Short description of previous completed similar assignments, including:

 - Signed reference letters from contactable references linked to these assignments (on client's letterhead),

As this procurement is expected not to exceed a maximum of R50 million, the 80/20 preferential procurement measure is applicable. In order to achieve specific goals, a maximum of 20 points will be awarded to a tenderer for broad-based black economic empowerment as follows:

- B-BBEE status Level 1 contributor: 20 points
- B-BBEE status Level 2 contributor: 16 points
- B-BBEE status Level 3 contributor: 10 points
- B-BBEE status Level 4 contributor: 8 points
- B-BBEE status Level 5 contributor: 6 points
- B-BBEE status Level 6 - 8 contributor: 0 points
