1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals

stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or

APPOINTMENT OF AN ACCREDITED ELECTRICIAN

1. INTRODUCTION & BACKGROUND

- 1.1 The National Economic Development and Labour Council (Nedlac) is a statutory body that was established through Nedlac Act No. 35 of 1994 and operates under the terms of its own Nedlac Constitution. Nedlac's vision is to promote growth, equity and participation through social dialogue.
- 1.2 Nedlac has one office nationally with an employee compliment of +-55 employees and external stakeholders/social partners. The Nedlac office is situated at 14A Jellicoe Avenue in Rosebank, Johannesburg.

2. PURPOSE

- 2.1 Nedlac requires services of a qualified, experienced and accredited electrician to conduct inspections and functional testing as well as the replacement of faulty accessories on the electricity system at Nedlac House, to ensure full electrical compliance.

3. SCOPE OF WORK

The inspections should cover **all aspects** of electrification including, plug points, lights, power surge and lightning arrestors fitted within each electrical distribution boards, etc.

- 3.1 Inspect all electrical distribution boards (ground, first, second floors, basement and guardhouse) to ensure that all power surge and lightning arrestors fitted within are fully functional and that arrestors show the correct lights that provide visual confirmation of the connectivity status of all electricals.

3.2 Rectify all identified faults and ensure that entire Nedlac building's electrical installations are functional and are in accordance with SANS 10142-1.

3.3 Certify Nedlac building is in line with industry requirements for electrical wiring and installations compliance.

3.4 Service providers must attend a compulsory site visit prior to quoting.

4. REQUIREMENTS OF THE SERVICE PROVIDER

4.1 The successful service provider must meet the following mandatory requirements:

4.1.1 Have professional experience and understanding of electrical installations.

4.1.2 Have full understanding of SANS10142-1 regulations and deliver work according to the regulations.

4.1.3 Provide proof of up to date CIDB contractor grading of 2EB or higher.

4.1.4 Provide valid proof of registration as an Installation Electrician (IE) from the Department of Labour.

4.1.5 Provide an up to date letter of good standing with COIDA.

4.1.6 Issue Nedlac with required industry certification (CoC) upon completion of work.

4.1.7 Provide a minimum of five (5) signed reference letters from contactable references, for similar projects completed in past five years.

4.1.8 Submit proof of a minimum of five (5) similar projects with client name, description of the project, value of contract, period which the project was performed and contact details of the client.

4.1.9 Have a competent team with Installation Electrician (IE) certification from the Department of Labour, that will be dedicated to this project.

4.1.10 Supply and use SABS approved products.

5. SUBMISSION OF DOCUMENTS

5.1 In addition to the requirements of 4.1 above, service providers must submit the following documents:

5.1.1 Proof of CSD registration.

5.1.2 Completed SBD forms.

5.1.3 Valid BBBEE certificate or sworn affidavit.
