PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2022

1. GENERAL CONDITIONS

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or

1. INTRODUCTION

1.1 The National Economic Development and Labour Council (Nedlac) is a statutory body that was established through Nedlac Act No. 35 of 1994 and operates under the terms of its own Nedlac Constitution. Nedlac's vision is to promote growth, equity and participation through social dialogue.

2. PURPOSE

2.1 Nedlac requires the services of an accredited service to supply, install, and commission a solar system at Nedlac House.

3. BACKGROUND

3.1 Nedlac has one office nationally with an employee compliment of +-55 employees and external stakeholders/social partners. The Nedlac office is situated at 14A Jellicoe Avenue in Rosebank, Johannesburg.

4. SCOPE OF WORK

4.1 The service provider is expected to supply, install and commission the following:

- a) 1 x 12kw hybrid inverter;
- b) 3 x 5.12w lithium batteries;
- c) 16 x 475w solar panels;
- d) Roof mounted solar frames for tiled roof;
- e) Wiring and all required consumables;
- f) Minimum of 10-year warranty for inverter and battery/ies;
- g) Electrical Certificate of Compliance for entire installation, including solar integration to the building's AC/DC;

4.2 Provide warranty certificate/s.

4.3 Provide optimal training on the operation of the system, supported by system user-friendly documentation i.e. manuals.

4.4 Provide technical support and maintenance intervals on the system.

4.5 Workmanship guarantee.

4.2 Service providers must attend a compulsory site visit prior to quoting.

5. REQUIREMENTS OF THE SERVICE PROVIDER

5.1 The successful service provider must meet the following mandatory requirements:

- 5.1.1 Have professional experience in the supply, installation and commissioning of solar systems.
- 5.1.2 Provide proof of a minimum of five (5) years' experience in the supply, installation and commissioning of solar system.
- 5.1.3 Submit proof of a minimum of five (5) similar projects with client name, description of the project, value of contract, period which the project was performed and contact details of the client.
- 5.1.4 Provide valid proof of registration as an Installation Electrician (IE) from the Department of Labour.
- 5.1.5 Provide proof of up to date CIDB contractor grading of 2EB or higher.
- 5.1.6 Provide an up to date letter of good standing with COIDA.
- 5.1.7 Provide a minimum of five (5) signed reference letters from contactable references, for similar projects completed in past five years.
- 5.1.8 Provide certified copies of trade certificates related to the requirements of the project.
- 5.1.8 Have a competent team with Installation Electrician (IE) certification from the Department of Labour, that will be dedicated to this project.

6.1 In addition to the requirements of 5.1 above, service providers must submit the following documents:

6.1.1 Proof of CSD registration.

6.1.2 Completed SBD forms.

6.1.3 Valid BBBEE certificate or sworn affidavit.
