PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2022

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

3.1.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
- (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

1. INTRODUCTION

1.1 The National Economic Development and Labour Council (Nedlac) is a statutory body that was established through Nedlac Act No. 35 of 1994 and operates under the terms of its own Nedlac Constitution. Nedlac's vision is to promote growth, equity and participation through social dialogue.

2. PURPOSE

2.1 Nedlac requires the services of an accredited service provider for the servicing and maintenance of the HVAC system at the Nedlac House over a period of three (3) years.

3. BACKGROUND

3.1 Nedlac has one office nationally with an employee compliment of +-55 employees and external stakeholders/social partners. The Nedlac office is situated at 14A Jellicoe Avenue in Rosebank, Johannesburg.

4. SCOPE OF WORK

4.1 The service provider is expected to provide the following services:

- a) 3 x Quarterly minor service of the HVAC system per annum over three years;
- b) 1 x annual major servicing of the HVAC system over three years;
- c) Supply and replace faulty HVAC components when needed;
- d) Provide emergency repair services when needed;

4.2 Provide component and workmanship guarantee and warranty.

4.3 Bidders must attend a compulsory site visit prior to quoting.

5. REQUIREMENTS OF THE SERVICE PROVIDER

5.1 The successful service provider must meet the following mandatory requirements:

- 5.1.1 Provide a detailed service/maintenance plan specific to this project.
- 5.1.2 Be accredited to work on Samsung Air-conditioners/HVAC systems and provide up to date confirmation of accreditation by Samsung.
- 5.1.3 Provide proof of qualification related to working on an air-conditioning/HVAC systems.
- 5.1.4 Provide proof of a minimum of five (5) years' experience in the maintenance of air-conditioning/ HVAC systems.
- 5.1.5 Submit proof of a minimum of five (5) similar projects with client name, description of the project, value of contract, period which the project was performed, reference letters and contact details of the clients.
- 5.1.6 Provide proof of up to date CIDB contractor grading of 3ME or higher.
- 5.1.7 Provide an up to date letter of good standing with COIDA.
- 5.1.8 Provide certified copies of trade certificates related to the requirements of the project.
- 5.1.8 Have a qualified and competent team that will be dedicated to this project.
