- 1.1 The following preference point systems are applicable to invitations to tender:
- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
 - the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
- (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

1. INTRODUCTION

Nedlac requires a suitably qualified, experienced service provider to provide a comprehensive Employee Wellness Programme to Nedlac staff for a period of two (2) years.

2. BACKGROUND

The National Economic Development and Labour Council (Nedlac) is a schedule 3A public entity that falls within the Department of Employment and Labour. Nedlac is the vehicle by which Government, labour, business and community organisations seek to cooperate, through problem-solving and negotiation, on economic, labour and development issues and related challenges facing the country.

With the rise of the Covid19 pandemic, rising cost of living, use of AI and ever-changing world of work, employee wellness (mental, physical and financial) is priority at Nedlac. Nedlac is thus seeking a service provider who can provide the employee wellness services set out below to a staff compliment of 62 for a period of two years.

3. TERMS OF REFERENCE

3.1. The successful service provider will be required to:

- Provide confidential professional support services through a 24 hours unlimited access call centre for psychological and social wellbeing related issues for all employees and their immediate family members
- Services must be accessible in eleven (11) official South African languages
- Face-to-face counselling and E-care online support services through internet
- Educational/awareness raising sessions and individual consultations on all of the following areas, approximately twice during the period:

- Personal financial management.
- substance abuse.
- Women's health issues.
- Stress management.
- Healthy lifestyle and exercise.
- Diet and Nutrition; and
- Work/life balance
- Mental health
- Advice on Occupational Health for office and remote working
- Health and productivity management services in respect of non-communicable diseases and communicable diseases, including chronic illnesses

For the above, the service provider would be required to:

- Provide quarterly reports on the service utilisation and employee evaluation of the services.
- Market and promote the employee wellness services
- Collaborate with HR to organise and partake in the annual Nedlac Wellness Day
- Provide services aligned with the National Health Calendar
- Treat all information confidential; this applies to the information acquired before, during and after completion of the contracted period.

4. REQUIREMENTS OF THE SERVICE PROVIDER

The successful service provider must provide the following to demonstrate experience:

- 4.1. Detailed c.v. of the project manager and team members
- 4.2. At least three short descriptions of previous completed similar assignments, including:
 - Assignment name
 - Signed reference letters from contactable references linked to these assignments,
- 4.3. Proof of professional registration with EAPSA and HCPSA
- 4.4. Methodology and approach for the delivery of the full programme.

5. SUBMISSION OF DOCUMENTS

In addition to the requirements of 4.1. to 4.4. above, service providers must submit the following documents:

- Entity ownership type and BBBEE certificate/Affidavit.
- Completed SBD forms
- Proof of CSD registration

6. SELECTION AND EVALUATION CRITERIA

6.1 Evaluation criteria

As this procurement is expected not to exceed a maximum of R50 million, the 80/20 preferential procurement measure is applicable. In order to achieve specific goals, a maximum of 20 points will be awarded to a tenderer for broad-based black economic empowerment as follows:

- B-BBEE status Level 1 contributor: 20 points
- B-BBEE status Level 2 contributor: 16 points
- B-BBEE status Level 3 contributor: 10 points
- B-BBEE status Level 4 contributor: 8 points
- B-BBEE status Level 5 contributor: 6 points
- B-BBEE status Level 6 - 8 contributor: 0 points
